Lives Given In Service To Portland

Firefighting is an inherently dangerous profession, claiming dozens of lives annually across the United States. Physical exertion, smoke exposure, exposure to infectious disease, and psychological stressors are but a few of the factors that place firefighters at an increased risk for illness or death.

When a firefighter dies during an emergency response, the story makes front-page news, and the whole community mourns. But firefighters are also at risk of career-ending illnesses and injuries that may not garner media attention.

James Reed

August 21, 1881

Protection Engine, Company #4

Reed collapsed and died of an apparent heart attack after pulling a hand-pulled fire engine to a fire.

Interred – Lone Fir Cemetery – Firefighter’s Section, South 204



Fred Wagner

February 28, 1890

Firefighter

Wagner was fatally injured while testing a new fire engine at the corner of SW 7th and Salmon. He was struck in the head by a nozzle and never regained consciousness.

Tom O’Keefe

August 21, 1891

Firefighter

O’Keefe was killed while responding to a fire at 16th and “B” Street. He fell from the hose wagon while rounding a corner and was crushed beneath the wheels.

John G. Hewston

October 3, 1892

Firefighter

Hewston was at the scene of a fire in the Kamm Block when he was knocked from his ladder by a falling timber. He died of a fractured skull.

Tom Grenfell

March 25, 1896

Firefighter

Death was attributed to injuries received on a fire call in January of 1896. Grenfell assisted in hauling a fire engine up a steep grade to reach a house. He fell, badly rupturing himself. A few days before his death in March, he met with a similar injury, which convinced him to enter the hospital for an operation for a perforated appendix. He died at the hospital.

David Campbell

June 26, 1911

Chief

Campbell entered the structure fire at the Union Oil building to alert his crews of an impending building collapse. All others escaped before the building fell, crushing the Chief in the collapse.

William Higdon

June 6, 1912

Firefighter, Engine 6

Higdon was the driver of Hose 6 when a sudden lurch threw him beneath the wagon. His head was crushed beneath the wheel. He was rushed to the hospital and died soon after. Interred – Sugarfork Baptist Church Cemetery (Sugarfork NC) First Large Monument from Back Door



Emil G. Gustafson

March 16, 1916

Electrician, Fire Alarm Telegraph

Gustafson died when he came in contact with a 10,000-volt power line while working on the fire alarm telegraph wires.

Francis H. McCormick

August 15, 1919

Hoseman, Truck 1

McCormick and several other firefighters were knocked from a train trestle after being hit with a fire hose while fighting a fire at the Northwest Box Factory. He hit his head on the railroad track below and died the next morning.

Fred B. May

April 22, 1920

Captain, Engine 8

May was standing watch in the watchroom of Station 8. His crew found him at 7:30 pm, having suffered a stroke. He died minutes later.

Karl Gunster

June 15, 1921

Lieutenant, Engine 22

Gunster was suffocated at a fire on the third floor of the May Apartments. He was found lying on the floor, unconscious by another firefighter. He was dragged to a window where fellow firefighters could assist but it was to no avail.

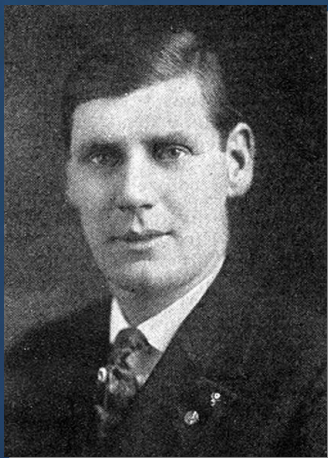
Oscar Lehman

October 3, 1921

Lieutenant, Engine 1

Lehman died as a result of a skull fracture sustained in a collision between two fire engines while responding to an emergency.

James S. Baldwin

June 19, 1922

Hoseman, Truck 1

A basement fire was extinguished and the basement flooded with several inches of water. Baldwin was descending the steps to the basement when his neck came in contact with a live electrical wire across the basement opening. He fell into the water while in contact with the energized wire and was electrocuted. He died on the scene.

Oscar B. Gabriel

October 25, 1922

Hoseman, Engine 12

Gabriel was killed when a wall fell on him during a fire at Washington High School.

Fred H. Rittenour

February 1, 1923

Hoseman, Engine 19

Rittenour died when he fell from a loft in the engine house at Station 19.

Adolph W. Wefel

June 1, 1923

Lieutenant, Engine 13

Wefel was killed when a brick chimney fell on him during the overhaul phase of a multi-house fire.

Interred – Rose City Cemetery – Section M, Lot 197, W Half, Grave 3



William E. Wilbur

April 7, 1926

Hoseman, Engine 18

Wilbur was at a house fire when, after climbing down a ladder, he had a seizure and died.

Lot 346, Grave 3



Charles A. Ryan

May 20, 1928

Hoseman, Truck 3

While rehearsing for the Rose Festival Parade Ladder Drill Team, a leather safety belt holding Ryan to Firefighter William McCreery broke, causing both men to fall from the ladder to their deaths.

Interred – Lone Fir Cemetery – Firefighter's
Section, South 146



William John McCreery

May 20, 1928

Hoseman, Truck 3

While rehearsing for the Rose Festival Parade Ladder Drill Team, a leather safety belt holding McCreery to Firefighter Charles Ryan broke, causing both men to fall from the ladder to their deaths.

Interred – Lone Fir Cemetery – Firefighter's
Section, South 143



Harry Josephson

July 23, 1928

Electrician, Fire Alarm Telegraph

Josephson died when he lost his balance and fell 25 feet from a power pole. He landed on the pavement and fractured his skull.

Walter W. McBride

December 19, 1929

Hoseman, Engine 9

McBride was found unconscious in bed at Station 9, possibly due to a stroke or hemorrhage of the brain. He was taken to the hospital and later pronounced dead.

Interred – Riverview Cemetery – Veterans Circle, Lot 76



Richard D. Laisner

July 4, 1930

Captain, Engine 31

Laisner had been working at the interior of a house fire. He entered the house and apparently became dizzy because he seated himself in a chair. A moment later, witnesses saw him pitch forward on the floor, and he was found dead when he was picked up. His death was attributed to heart disease.

Henry Krimbel

October 23, 1932

Hoseman, Truck 2

Krimbel fell through a skylight at a 3rd Alarm fire at the Counselor Apartments on August 16, 1930. He suffered spine and kidney injuries from the fall. He returned to work for a time but died on October 23, 1932, apparently due to kidney damage from the effects of the fall two years prior.

Clement M. Kemmer

April 21, 1933

Hoseman, Engine 8

Kemmer died of a heart attack while on duty at Station 8. He was playing handball as part of the physical fitness program.

Gustave Adolph Stephan

June 26, 1933

Lieutenant, Fire Marshal's Office

Stephan (a theater inspector) died of an apparent heart attack at 68 NE Stanton, where he stopped to rest after having taken ill while on duty. He died at that site.

Frank L. Kearney

January 7, 1934

Hoseman, Engine 21

Kearney died instantly in a collision between Engine 21 and Squad 1 as they both responded to an emergency at the Holly Dairy at 406 NW 14th Avenue. Nine other firefighters were injured in the collision.

Harry B. Morrow

July 1, 1934

Firefighter, Engine 23

Morrow died of an apparent heart attack while fighting an automobile fire.

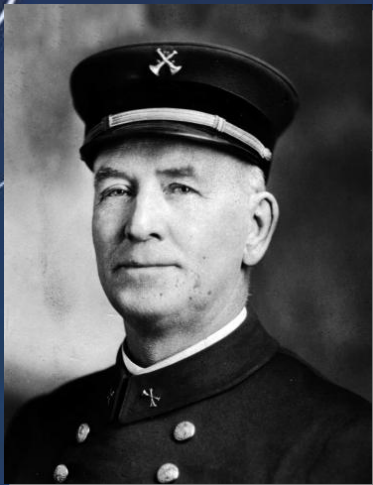
Harry U. Gardner

January 19, 1935

Engineer, Engine 28

Gardner was overcome by smoke and died of an apparent heart attack while fighting a house fire at 2305 NE 51st Avenue.

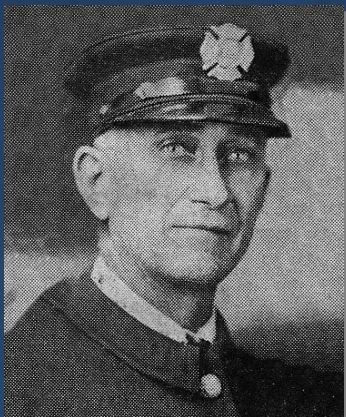
William D. Heath

March 18, 1935

Battalion Chief, Station 22

Heath had overseen his crews at a fire at the Hotel Lindquist during the night. After returning to the station, he did not feel well and went to bed. Sometime in the night, he suffered a heart attack. His crew heard him and tried to revive him, but he was unable to survive.

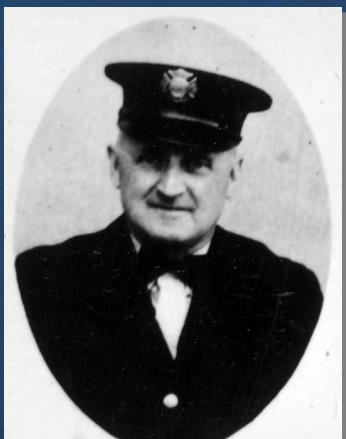
Frank E. Platt

March 11, 1937

Hoseman, Engine 10

Platt was performing his daily checks on Engine 10 when the driver mistakenly stepped on the starter. The Engine was in reverse and lurched backward, crushing Platt into the wall. He died at the scene.

Harry R. Howard

December 31, 1939

Hoseman, Engine 36

He had an apparent heart attack while on duty at Station 36.

Ernest W. Bills

June 3, 1940

Firefighter, Engine 4

While responding to a fire at the Portland Furniture Manufacturing Company, Bills' canister mask failed and he was overcome by smoke. Other firefighters tried to rescue him. One would-be rescuer, Carl Markstrom, would also die during the rescue attempt. Bills did not respond to lengthy rescue attempts.

Carl G. Markstrom

June 3, 1940

Junior Captain, Engine 4

During a fire at the Portland Furniture Manufacturing Company, Markstrom found Firefighter Ernest Bills unconscious due to a failed canister mask. Markstrom tried to rescue him but suffered the same mask problem. He too would fall unconscious. Both men were rescued but failed to respond to lengthy attempts to revive them.

Peter P. Kumpf

December 5, 1940

Senior Captain, Engine 23

Kumpf succumbed to a heart ailment while on duty at Station 23 and was taken to a local hospital. He died a few hours later.

Owen D. Peterson

October 28, 1943

Captain, Last assigned Engine 5

Pension determination – ruptured appendix and peritonitis.

Joseph Frederick Allerton

October 2, 1945

Captain, Fireboat 3

Allerton commanded the Fireboat Laudenklos at the Oregon Shipyard fire. He reported sick following shift and never returned to duty. He died of bronchial pneumonia a few weeks later..

Elmo St. Clair Bradford

October 25, 1945

Captain, Engine 15

Bradford and his crew were dispatched to a fire at SW Hoffman Road and Broadway Drive. While fighting the fire, Bradford suffered a stroke or heart attack and died at the scene.

William M. Inglesby

July 19, 1946

Captain, Engine 33

Inglesby died while on duty at Station 33 of Coronary Thrombosis.

Gregory A. Warner

December 30, 1946

Senior Captain, Engine 6

Warner responded to a fire with Station 6 and, upon return to the station, suffered a heart attack and died a week later.

Marion R. Stark

March 31, 1947

Battalion Chief 3, Station 8

Stark was found dead in bed at fire Station 8 in the morning following his shift.

Alfred J. Berg

November 2, 1948

Engineer, Engine 33

A 2nd Alarm fire was called at the Independent Marine Propeller Manufacturing Company. Berg and his crew on Engine 33 responded. While fighting the fire, Berg had a heart attack. The first aid squad from Truck 7 spent 30 minutes trying to revive him, but he would be pronounced dead at the scene.

Daniel C. Shaw

April 24, 1949

Senior Captain, Engine 14

Shaw was directing his crew at a house fire at 432 NE Russell Street. He collapsed while raising a ladder. His crew tried to resuscitate him but he died at the scene.

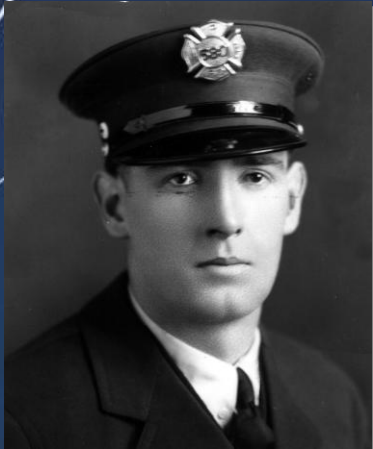
Victor D. Brown

Brown died of acute pneumonia and generalized arteriosclerosis .

While responding to a fire at 2203 SE Orange, Truck 4 collided with a Rose City Transit Company buss. Metcalf was thrown from the Truck. Four other firefighters and several bus passengers were also injured. Metcalf was transported to the hospital where he was pronounced dead.

About The Portland Firefighters Association Memorial

This display was dedicated in June 2019. It incorporates many distinctive elements of Portland Fire & Rescue in its presentation.

The headpiece is carved in the shape of the Firefighters Cross. While sometimes thought to be a Maltese Cross or Florian Cross, the design is actually unique to the United States Fire Service, first designed for FDNY in 1867. It has come to serve as a universal symbol of the United States Fire Service.

The headpiece is engraved with a Portland Firefighter-specific logo used for, and with, the Firefighter's Section of Lone Fir Cemetery. The words Honor, Service, and Sacrifice are also engraved to indicated the accolades given to the members listed in the book.

The book itself is cradled in a framework of wood and supported by the jacket of fire hose, the tool firefighters rely upon to protect themselves and others in the commission of their duties.

The display is braced by a ladder, which is decorated by a fire axe. These are principle tools of a firefighter in service to others.

The display is capped by a fire helmet. The helmet is also an essential tool that protects the firefighter so they may continue their duty, even in perilous conditions. It is colored black, to be absent of rank and to designate the place at which all firefighters begin their career, as a trainee.

The display is made from Pacific Northwest Douglas Fir. This is the preferred material for fire department ladders because of its strength and durability, qualities that well suit the firefighter.
